### AGREEMENT

The photographic services described by this agreement are for the client only. No other person or entity has any interests or rights in regard to these services. The photographic services described above represent the full extent of services to be provided. No other agreement in any form exists between the photographer and the client.

A deposit of \$350 is required to book your wedding date. A deposit of 50% of the remaining balance [\$ \_\_\_\_\_ ] is due at least 30 days before the date of the wedding and the remaining balance [\$ \_\_\_\_\_ ] is due on or before your wedding date. Photos will not be taken or delivered without payment of the required deposits. If client cancels more than 90 days before wedding date a cancellation fee in the amount of \$150 will be withheld from deposits paid plus an additional \$150 if engagement photos have been taken. Cancellations within 90 days of wedding will result in no refund of any deposits paid.

Any photo print or album allowance provided with this package must be used in full within 6 months of the wedding date. Any unused allowance will be liquidated at that time and your digital images may no longer be available.

If a photo CD is included with the wedding package, the photographer grants full rights to the client to reproduce or print the included photos without any restrictions and the photographer has the right to use images of your wedding for website display or advertising purposes.

Care will be taken for the proper composition, exposure, capture, processing, storage, and delivery of photographs. However, in the event the photographer fails to comply for any reason with the terms of this agreement or if any dispute should arise between the photographer and the client concerning any aspect of the photographic services described in this agreement, the photographer's liability is limited to a refund of deposits.
